


**INDEPENDENT AUDITOR'S LIMITED REVIEW REPORT ON STANDALONE UNAUDITED

**Review Report to the Board of Directors of
Libord Securities Limited**

1. We have reviewed the accompanying statement of unaudited financial results of **Libord Securities Limited** ("the Company") for the quarter and nine months ended December 31, 2023 ("the Statement"). This statement is the responsibility of the Company's Management and has been approved by the Board of Directors.
